Special Magistrate ruled in favor of the town for cost of Prosecution in the amount of \$134.50 payable within 30 days

- **4.** 20220131 310 Hatchineha Rd. (272816-828005-000020) –Raymond Lugo Mercado- Lisa Harris presented this case to the Special Magistrate. The owner was not present. Photos were submitted and admitted into evidence. The property was found to be in violation except for The Prohibited Use Violation and owner was given 10 days to come into compliance. If owner fails to do so in the time allotted there will be a \$100 a day fine imposed until said property is found to be in compliance. Special Magistrate ruled in favor of the town for cost of Prosecution in the amount of \$109.50 payable within 30 days
- 5. 20230001 80 6th St N (272817-829502-000052 Robert Perrault Bracken Jr. Homestead Trust and Robert P. Bracken Jr. Lisa Harris presented this case to the Special Magistrate. The owner was not present. Photos were submitted and admitted into evidence. The property was found to be in violation but has since come into compliance. Special Magistrate ruled in favor of the town for cost of Prosecution in the amount of \$176.80 payable within 30 days
